



## INVITATION TO BID

for the

### SUPPLY AND DELIVERY OF ONE (1) UNIT MULTI-PURPOSE VEHICLES

1. The National Police Commission (NAPOLCOM), through the approved National Expenditure Program (NEP) for FY 2024, intends to apply the sum of **One Million Four Hundred Thousand Pesos (₱1,400,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the supply and delivery of one (1) unit Multi-Purpose Vehicles (MPV). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NAPOLCOM now invites bids for the above Procurement Project. Delivery of MPVs is required within thirty (30) calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project within five (5) years. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184
4. Prospective Bidders may obtain further information from NAPOLCOM and inspect the Bidding Documents at the address given below from 8:00 am to 4:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on April 30, 2024 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (₱5,000.00).
6. The NAPOLCOM will hold a Pre-Bid Conference on May 8, 2024, 10:00 a.m. at the NAPOLCOM R6, Fuentes-Ledesma Sts., Iloilo City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 21<sup>st</sup> of May 2024. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on May 21, 2024, 10:00 a.m. at the NAPOLCOM R6, Fuentes-Ledesma Sts., Iloilo City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The NAPOLCOM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA-No. 9184, without thereby incurring any liability to the affected bidder or bidders.
