WHEREAS, the procuring entity, National Police Commission (NAPOLCOM) Regional Office VI, through its Bids and Awards Committee (BAC), posted an Invitation to Bid for the Supply and Delivery of One (1) Unit of Multi-Purpose Vehicle at both the Philippine Government Electronic Procurement System (PhilGEPS) and in a conspicuous place within the premises of the NAPOLCOM Regional Office VI building as determined by the BAC;

WHEREAS, the General Appropriations Act (GAA) appropriated the amount of One Million Four Hundred Thousand Pesos (P1,400,000.00) only under FY 2024 National Expenditure Program (NEP) for the implementation of the project Supply and Delivery of 1 unit of Multi-Purpose Vehicle;

WHEREAS, the NAPOLCOM Regional Office VI through its BAC posted the Invitation to Bid in a conspicuous place within its premises as determined by the BAC from April 5 to April 29, 2024;

WHEREAS, the NAPOLCOM Regional Office VI through its BAC likewise posted the Invitation to Bid at the Philippine Government Electronic Procurement System (PhilGEPS). However, when the required data fields on the PhilGEPS were being filled out, it was mistakenly and inadvertently construed that the posting date should/would also coincide with the last day of posting the advertisement, thus, the Invitation to Bid in PhilGEPS was posted from April 5 to April 17, 2024 only;

WHEREAS, such mistake and inadvertence only came to the knowledge of the BAC on April 23, 2024. Notwithstanding, the BAC continued with the original schedule of the Opening of Bids which was set on April 29, 2024 at 10:00 a.m.

WHEREAS, there was no bidder who signified their intention to participate, purchase the bid documents until the closing of the Invitation to Bid on April 29, 2024;

WHEREAS, there was a "failure of bidding" as defined under Sec. 35 (a) of R.A 9184, which provides that "There shall be a failure of bidding if: (a) No bids are received x x x";


WHEREAS, conduct of mandatory review prior to its reposting was made last April 29, 2024;




