RESOLUTION NO. 2024-003

REVISION IN THE TECHNICAL SPECIFICATIONS OF THE MULTI-PURPOSE VEHICLE (MPV) SUBJECT OF A COMPETITIVE PUBLIC BIDDING OF THE NAPOLCOM REGIONAL OFFICE VI, THEREBY REPEALING NAPOLCOM REGIONAL OFFICE VI BIDS AND AWARDS COMMITTEE RESOLUTION NUMBER 2024-001

WHEREAS, the Office of the Vice Chairperson and Executive Officer issued a Memorandum, dated March 13, 2024, to all NAPOLCOM Regional Directors informing them that there is an allocated budget of One Million Four Hundred Thousand Pesos (Php 1,400,000.00) for the procurement of one (1) Multi-Purpose Vehicle (MPV) per region under the approved National Expenditure Program (NEP) for FY2024 shall be released by the Department of Budget and Management (DBM) directly to the respective regional offices;

WHEREAS, the said Memorandum directed all Regional Directors to prepare the necessary documentation for the conduct of Competitive Bidding for the procurement of one (1) unit of MPV;

WHEREAS, also attached to the said Memorandum, for their guidance, is the proposed Technical Specifications of the MPV approved and to be adopted by the NAPOLCOM Central Office Bids and Awards Committee;

WHEREAS, the NAPOLCOM Regional Office VI Bids and Awards Committee notes that the said Memorandum serves as a guidance to the Regional Offices as to the proposed Technical Specifications of the MPV;

WHEREAS, the NAPOLCOM Regional Office VI Bids and Awards Committee adopted the said Technical Specifications in Resolution Number 2024-001 dated March 25, 2024;

WHEREAS, there was no bidder who signified their intention to participate, purchase the bid documents until the closing of the Invitation to Bid on April 29, 2024;

WHEREAS, there has been a failure of bidding as defined under Sec.35 (a) of R.A. 9184, which provides that *"There shall be a failure of bidding if: (a) No bids are received x x x"*;

WHEREAS, in Resolution Number 2024-002, the NAPOLCOM Regional Office VI Bids and Awards Committee recommended for approval of the Head of Procuring Entity the declaration of the first failure of bidding and reposting of the Invitation to Bid for the Supply and Delivery on One (1) Unit of Multi-Purpose Vehicle;

WHEREAS, the said recommendation was duly approved by the Head of Procuring Entity;

WHEREAS, pursuant to Sec 35.2 of the Revised Implementing Rules and Regulations of R.A. 9184, in order to determine the reason for the failed bidding, the BAC, on April 29, 2024, conducted a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates;




WHEREAS, pursuant to Sec. 35.3 of the Revised Implementing Rules and Regulations of R.A. 9184, based on the findings of the mandatory review, the BAC finds it necessary to revise three (3) technical specifications to make it more competitive, subject to the required approvals, and conduct re-bidding with re-advertisement and/or posting as provided for in Section 21.2 of the same Rules;


WHEREAS, the three (3) technical specifications that were revised are as follows;






